### Edson Family Preservation Services Program Requires a: .5 PROGRAM SUPERVISOR/.5 Family Preservation Worker

**Hours:** 40 hours per week — 20 hours Program Supervisor/20 Hours Family Work  
This position requires a flexible work schedule and may include evenings and weekends

**Details:** The Program Supervisor is a position responsible for providing supervision, support and counseling to youth, their families, and the staff team in the Family Intervention Program. They oversee specific operational and service delivery components as related to the families and staff. They ensure the delivery of quality services, and that the overall care, safety and needs of the families are being met. The Program Supervisor leads the team that collaborates with the families, their support group and the staff to assist the families in achieving their goals. Family Workers are responsible for carrying out direct case management activities, including assessment of family issues, skill development, utilization of community resources and the family's support network. The workers will need to assist the families in developing goals and will provide various intervention strategies, counseling or facilitate groups to help families address issues that they are facing.
